Commentary and Overview from JAR2

August 15, 2019 From Mordovia. After my arrival at the prison. I had spent the night in my vehicle outside of the prison and wrote the following on my aging laptop as I was waiting to find out if I would be allowed to stay with my son in the prison for four days. I will go into all of the details of the trip in another part of this article at a later date.

I am a targeted publisher and investigative journalist and geopolitical specialist and what you are about to read I swear to be the truth the whole truth and nothing but the truth, I hope you appreciate the seriousness of what I am about to partake and are able to synthesize the truth contained herein into your own world view and that by doing so you may

attain a deeper understanding and perhaps gain a bit of knowledge which in my advancing age and all but total isolation is all that I have left to offer the world, and you my dear reader, whoever you may be.

The damage has already been done and the point of bringing about any change or finding justice to what has already transpired is not something that will be able to be accomplished, of this I am convinced. Those in power have proven to be completely deaf and indifferent to the fate of my son, myself and my family. By their actions they have proven that the real power in the Russian Federation is not (or as the case may be WAS not) in the hands of the state, the judiciary or in fact any of its bodies. This has been proven by the case of my son and what was allowed to be done to us every step of the way. I must recall that before everything that has occurred I officially asked for protection for me and my family, both in writing and to all of the government officials with whom I had contact, including my controllers, and absolutely nothing was done to stop what they had planned and carried out against us.

Everyday I wake up with statements and messages from my enemies rolling around my head and there is nothing that can make that go away. Today it was the CIA Operatives who kept telling me something bad would happen. Something so bad I would kill myself. Yes they were right and they were right about killing my citizenship bid, ending my marriage and having my son arrested on fabricated charges. How many millions they spent on all of that and on the targeting of me and my work is unknown but it can not have been cheap.

There are still many many things that I have never written about and there are many things left to be said and it is time to finally say them and set the record straight.

One of the most evil parts of the conspiracy that I have uncovered involved the Chabad Lubavich mafia which in fact runs the Russian media and circles extremely close to the Kremlin with agents inside the Kremlin walls.

The "Director"

I was not only a newsreader and a special correspondent and an investigative journalist for the Voice of Russia but I was also in charge of editing, updating news and proofreading the Voice of Russia's English web site and also placed in charge and direct control of social media. Needless to say I was working like nine men and still not making ends meet in Moscow, one of the most expensive cities in the world. At the time of these events I was married and my ex-wife expecting a child, with my termination coming on the day Rossiya Sevodnya found out about her birth, but that is another story.

The reason I mentioned all of that is because there were always extra jobs and people who called for special projects and voice work. My voice was well known and was used as the voice of the ASEAN Summit, the Universiade and other events. I was not only the English Voice of Russia but also the English voice of the Russian military orchestra events and other Russian bodies including GosZnak who used me for their Olympic coins programs.

After the two failed attempts by McFaul to have me thrown in prison in Russia and evicted back into the hands of the CIA, I was very very cautious as to who I worked for, met and about my personal security in general. Unfortunately my son did not listen when I warned him multiple times for months and months that he needed to be more careful. Unfortunately he had to learn that lesson the hard way. I was getting calls of almost every nature imaginable all of the time from people offering me work, trying to get information and even making death threats.

One of the people who called was an Anatoly Vlasev who claimed he was working on a film titled "The Tourist from San Francisco". Before the first session I checked him out and as he had a site for the film and appeared to have an office and staff I took him at face value. However the film was rather strange yet he needed an American male voice from California and I fit the bill. The film was about an FBI agent in Moscow and mafia machinations in the 1990s and had been in post production for years and years. At the time I thought he was just a bad director as he was unknown but he lived in Barvikha (an elite region in Moscow) and paid well so I agreed. Now it all seems much much darker especially when it has become clear that we are up against cold blooded killers and criminals who are committing treason and filling orders for the CIA and in his case the FBI and directly from Michael McFaul.

I completed four sessions with him and his operator and of course as an investigator was paying close attention and asking questions all of the time because something just did not add up. They knew all of the announcers at the Voice of Russia and made this clear, they also appeared to be doing nothing else except working on a really bad B film for over a decade. Two at my sessions were in a very pricey Moscow River front "studio" a few blocks from the US Embassy. Another was at a new and very technologically advanced and highly equipped studio in a very expensive ground floor office of a new elite building near MosFilm and the last was at his home in Barvikhka where the events I am about to describe took place.

The last "job" occurred in 2015 with the first taking place in 2012 after the appearance of Edward Greenberg "Snowden", and were all for the same film.

My job was to do voice overs of the various actors, in particular the FBI Agent, but these were not simple voice overs. I had to reproduce the exact voice of each person for certain parts where they claimed there had been bad quality, with the reasoning that the actors, in particular the star, could not return to Moscow. It is a shame I did not keep records of the sessions and have no exact copies of everything I said. I did such a good job that the actors who were brought in later took my own voice in the voice overs for their own. The individuals could not tell the difference. I was quite proud of myself but there has been one thing nagging me in the back of my mind for years now especially as the film has never to my knowledge been released&hellip;

What if these recording were used against me? I had been recorded playing the role of an FBI Agent. I had been recorded playing the role of a criminal. I had stated some pretty damning stuff if the recordings were taken out of context. I can not remember in complete detail every word but there were situations regarding murders, FBI operations,

theft, crimes and other sordid issues.

Another thing has been the fact that this slimy little man must have been making millions judging from his digs, but the B film and all he said did not fit. After the last meeting at his home I came to the conclusion that what he really produced as Kompromat, at least in my case. That was the only way that everything fit.

The last meeting at his home was extremely tense and like I said occurred in 2015. The following is a description of that meeting.

I got an unexpected call one day and he asked me to come and "fix a few minutes of audio". He offered me a ridiculously low price and I almost refused but I was already in deep trouble financially so I ended up agreeing to drive to the other side of Moscow to his home in Barvikha.

When I got there he was actually quite rude, did not offer me coffee or anything to drink and made several rude comments. I patiently listened and did the job quickly in a matter of less than an hour and then he invited me to have some soup before I drove back home. It was this conversation and his actions at the dinner table that have haunted me for years now. Except now I believe I have the answer given everything I have learned and some new facts I have been investigating which I can not go into yet.

Note: As an investigative journalist I am reporting events and facts as they occurred

First he was trying non-stop to get information from me regarding my citizenship filing and asylum and what I was doing exactly. Then there came the big claim. We were talking about Dmitry Kisilev and how I had been poisoned in his offices when this slimy little man stated:

"I know Dmitry Kisilev quite well. I used to get young boys for him in the '90s."

I of course asked questions thinking maybe he was talking about someone else and not Dmitry Kisilev but he insisted. Mentioning something about Masons which I did not connect at the time.

As we were talking about the loss of my job and my poisoning in the offices of Kisilev I enquired if in fact he could help me in finding a job and straightening out the situation.
