I'm not, because it is absolutely 100% clear that we are winning, not only my case, but we're winning this entire war against the evil forces that are now being exposed, not just in my case, but also in the horrific genocide that's being committed in in the Middle East.

And on top of all this, all of a sudden, bright sunlight, which continues to be the best of disinfections, is shone directly into those very, very dark reaches in which the likes of Jeffrey Epstein, Jimmy Savile, Hugh Edwards, Mohammed Al-Fayed, and now Sean Combs lurk, demonstrating that pure evil is calling the shots at the top levels of politics, the media, the entertainment industry, and business. But at night, he really goes crazy. He all of a sudden, out of the blue, starts to scream and yell, swearing at the top of his lungs. And without warning, he smashes heavy objects against not just the steel door of his cell, but also at the wall separating his cell from mine on the other side of which my bed is. Imagine that at two or three o'clock in the morning. At any rate, you get the idea. But again, just like Joe Friday used to say the TV show Dragnet, just the facts.

I'm just giving you the facts. I'm not asking for anyone's commiseration.

I am my father's and my mother's son, and I am my grandmother, Emma's grandson.

I have my entire extended family's full support. I have my wife's full support, and I have your full support, my friends. What do they have? Nothing. Only the support of flying monkeys and the thrill of getting thrown under the bus if one of them likes it.

Well, based on all this, I do not get mad, I get even.

I get even through justice. And that, in closing, reminds me of a phrase Ronald Reagan once coined when he said we're going to make them feel the heat. I don't think that Ronald Reagan was fully aware of the role that they intended him to play in this obscene systems show. But I believe that he meant well. And he has a sense of humor, sometimes almost Monty Python-like humor.

So that's it. We're going to make them feel the heat. We're going to make them feel the heat because we're going to make sure that justice is done.

And this justice will send them straight to hell. Let's keep going.
